

FIMM ACADEMIC CERTIFICATE REVIEW GUIDE

As stated in **Appendix 1-A & 1-B (ii) of the FIMM's Consolidated Rules:**

An individual must meet the minimum academic qualification of having Sijil Pelajaran Malaysia (SPM) with credits in any three (3) subjects or its equivalent.

1. Credit Requirement in SPM

The applicant must obtain at least three (3) subjects graded from A1/1A/A+ to C6/6C/C as follows:

2. Sijil Am Pelajaran (SAP)

If an applicant has no three (3) credits in SPM, **the applicant must retake the SPM or sit for July Paper.**

3. Combination of SAP and SPM Certificates

***Note: Credits in two (2) same subjects are considered as one.*

4. Sijil Vokasional Malaysia (SVM)

Sijil Vokasional Malaysia (SVM) certificate is considered as SPM equivalent and is acceptable provided the minimum requirements stated in the link below are met.

- a) Type **Computer Science** in the **Name of Qualification** column
- b) Choose **Diploma** at **Type of Qualification** column
- c) Click on **Search** button

 - ✓ Verify the Institution is accredited
 - ✓ Verify the qualification exists in the Issuing Institution
- c) **Partner with Verification Agencies or Third-Party Verification Services (if possible)**
- d) **Fraud Detection Training**
- e) **Social Media Screening**
